The fields at Michael Field are not draining properly and retaining water. The rails at Michael Field need replaced and more parking is needed.


Letters have been sent out to businesses for July 4th Fireworks. A Master of Ceremony is need for July 4th.


A PROCLAMATION

ANNOUNCED FOR
NOVEMBER GENERAL ELECTION


The Grant County Commission hereby orders that Pursuant to WV Code §3-10-8, as a result of the resignation of the former Grant County Assessor, a vacancy for the unexpired term for that office will be placed on the November General Election ballot.

A special candidate filing period is established pursuant to WV Code §3-10-1, and eligible candidates, nominated pursuant to the proper procedures as outlined in WV Code §3-5-19(a)(4), or WV Code §3-5-22, or WV Code §3-5-23, shall file a certificate of announcement and the statutory \$555.73 filing fee with the Grant County Clerk for no parties, no later than August 1st, 2022, and for recognized parties, no later than August 22nd, 2022.
